# **EMERGENCY AND FIRST AID PROCEDURES:**

**EYES -** FOR EYE CONTACT, IMMEDIATELY FLUSH EYES FOR AT LEAST FIFTEEN MINUTES WITH RUNNING WATER. HOLD EYELIDS APART TO ENSURE RINSING OF THE ENTIRE EYE SURFACE AND LIDS WITH WATER. IF PHYSICIAN IS NOT AVAILABLE, FLUSH FOR AN ADDITIONAL FIFTEEN MINUTES. GET IMMEDIATE MEDICAL ATTENTION.

**SKIN** - FOR SKIN CONTACT, IMMEDIATELY REMOVE CONTAMINATED CLOTHING AND SHOES UNDER A SAFETY SHOWER. WASH AFFECTED AREAS THOROUGHLY WITH PLENTY OF WATER AND SOAP FOR AT LEAST FIFTEEN MINUTES. DISCARD OR DECONTAMINATE CLOTHING BEFORE RE-USE, AND DESTROY CONTAMINATED SHOES.
